MEMBERSHIP REQUIREMENTS

This application is to be signed by the applicant and the sponsor and submitted to the Membership Committee (membership@hancespointyachtclub.com). Applications may take up to 45 days for processing. Applicant will be notified upon membership approval by the Board of Directors.

Upon approval and receipt of an initial invoice applicant will have fifteen (15) days to submit payment, proof of liability insurance and any additional requested information. If dues, fees, liability insurance documentation and required information are not received within the prescribed time, the Board of Directors may consider this Application void.

By signing this Active Membership Application and if accepted for membership I agree to:

1. Abide by the terms and rules herein as well as the Club Constitution, By-Laws, Dues and Fees Schedule and the Rules and Regulations now in force or hereafter enacted. Recognize that I am on probation for one year as per Article X, Section 12 of the Club Constitution.
2. Hold blameless Hances Point Yacht Club, Inc. and its governing body for any loss or damage to boats or other property or contents while on Hances Point Yacht Club, Inc. grounds or moorings and to assume full responsibility for the conduct and safety of myself and all family members and guests while on Hances Point Yacht Club, Inc. grounds or moorings.
3. Hold blameless Hances Point Yacht Club, Inc. and its governing body for any injuries/medical costs I/we sustain while performing club maintenance on grounds, moorings club equipment or property and to assume full responsibility for the conduct and safety of myself and all family members and guests while on Hances Point Yacht Club, Inc. grounds or moorings.
4. Maintain at least \$300,000 liability insurance on my boat at all times while my boat is on Hances Point Yacht Club, Inc. grounds or moorings, and to provide with my annual dues and fees payment, proof of insurance coverage consisting of the Insurance Carriers name, owner's name, policy number, policy coverage, liability amount, insurance agent's phone number and effective dates. (Note: Liability insurance is required on documented boats, all boats/dinghies requiring registration and all boats in excess of 12 feet in length.)
5. Pay all dues and fees promptly when billed. Any unpaid dues and fees will be cause for Hances Point Yacht Club, Inc. to refuse to launch or to allow removal of my boat from Hances Point Yacht Club, Inc. grounds. Permission is specifically granted to the Club to move my boat to a remote storage area at the discretion of the Grounds Committee.
6. Forfeit on April 1st, if dues and fees are not paid and liability insurance documentation is not provided, all rights and privileges afforded to paid members until such time as all dues and fees have been paid in full and liability insurance documentation has been provided; unless other arrangements have been made with and approved in writing by the Board of Directors or the Financial Secretary. Late payment or non-compliance will automatically result in the Financial Secretary administratively placing me on 'mooring, motor locker, & dinghy storage when available' lists & advising the Board of Directors my membership status has changed to not-in-good-standing.
7. Immediately remove my boat/property from Hances Point Yacht Club, Inc. upon termination of my membership. Until my boat/property is removed, or if sold, until the new owner removes the boat/property, I accept full responsibility for all accumulating dues and fees as though no termination of membership or change of ownership had taken place.
8. Notify the Financial Secretary and Fleet Measurer immediately of any changes to boat ownership, or size of vessel.
9. *Attorney's Fees.* In the event of litigation to enforce the terms of the Club By-Laws, Rules and Regulations, or to collect any monies due from a member, the Hances Point Yacht Club, Inc. shall be entitled to attorney's fees, court costs, witness fees and all expenses of suit.

GENERAL INFORMATION

- Hances Point Yacht Club, Inc. is a private club. The club facilities consist of the club house, grounds, piers, floating docks, moorings, boat handling and maintenance equipment.
- Use of heavy equipment is prohibited unless specifically authorized by the Commodore, Grounds, Maintenance, Waterfront or Moorings Committee chair.
- The security and safety of each boat on club property, docks or moorings is the owner's responsibility.
- Members do all of the club maintenance work and boat handling, launching and hauling.
- Hances Point Yacht Club reserves the right to move any boat at any time for the good of the club. Placement of boats on club grounds will be determined by the Commodore, or designated yard boss.
- Each mooring is assigned according to boat size and weight. Every effort is made to assure the safety of each boat during average conditions but under no circumstances will Hances Point Yacht Club, Inc. assume responsibility for any mooring or boat during any conditions. The security and safety of each boat on club property, docks or moorings is the owner's responsibility.
- The Mooring Committee reserves the right to refuse to install or to immediately replace (at the owner's expense) a mooring pendant that is not in safe condition. Each member should periodically inspect the condition of his mooring pendant and request immediate repair or replacement if necessary.
- If a mooring has been assigned to a member's boat, that boat may be placed on its assigned mooring anytime in the spring after the mooring pendant has been installed and all dues, fees have been received.
- Boats must be off the moorings by the date determined by the Mooring Committee and posted in the clubhouse. Late removal from the mooring may result in penalty fees as set by the Board of Directors.
- Winter storage is available on the Club grounds. It is the owner's responsibility to provide boat stands or a trailer for storage. Boat cradles are not permitted.
- Only one boat per member may be moored at Hances Point Yacht Club, Inc.
- Members are permitted to have a second boat stored on Club grounds but Second Boat Fees will be assessed.

2016 FEES AND DUES

- One-time Initiation Fee upon joining the Club: \$350
- Annual Membership Dues: \$300
- Maintenance Fee - \$315 first year, thereafter members are expected to complete 35 hours of service time on approved club maintenance each year or pay a fee of \$9.00 for each hour (up to 35 hours / \$315.00) not performed.
- Maintenance Fixed Fee - \$85.00
- Boat Storage - \$13 per foot in length per year
- Dinghy Rack rental: \$10
- Motor Locker rental: \$10
- Second Boat Maintenance Fee: (on the hard only): \$400
- Second Boat Storage Fee: \$13 / linear foot
